Under the Buy-back Programme, the Company has acquired a total of 247,000 treasury shares, representing 0.75% of Renta Corporación's current share capital, which will be delivered to employees and directors of the Company in execution of the current remuneration programs.

The acquisition of treasury shares under the Buy-back Programme has been reported to the market in accordance with the provisions of article 2.2 of the Commission Delegated Regulation (EU) 2016/1052 and has been carried out in accordance with the terms and conditions of the said Regulation.
